You are being asked to take part in my research study. Before deciding it is important that you understand why my research is being done and what it will involve. Please take time to read the information carefully and discuss with other people if you would like. Please do not hesitate to ask me if there is anything that is not clear or if you require more information. My contact details have been provided at the bottom of this sheet. This study has been approved by the Applied Criminology and Forensic Studies Department Ethics Committee and follows the ethical guidelines of the British Society of Criminology.

What you are asked to do

As part of my research project, I am aiming to study "The effect of stutters on voice recognition devices". I will ask you to say certain sentences and record them for my research. The sentences will be attached with this participant information sheet. The sentences are on page 4 of this document. You will record the sentences on a smartphone or recording device and then email these to the email stated at the bottom in bold of the information sheet. The email will be put in to a closed folder that I only have access to and will be stored in there until I have transferred the recordings over to a folder created on my documents. The email will be deleted after I have transferred the recordings. The recordings will be stored on a computer which is password protected, and your sample will be labelled with the unique identifier that you have provided. Please use your favourite book as your unique identifier. An example of this is: Born to Run. This will protect your identification under the Data Protection Act 2018 and also General Data Protection Regulation (GDPR). Please see the document below that discusses the University of Winchester's GDPR regulations.

Consent

Please take the time to decide whether or not you wish to take part. It is voluntary. It is up to you to decide if you take part or not in my research. By sending your voice recordings you are consenting to me using your voice samples for my research. This is to protect anonymity. I have signed the consent form attached and will fully ensure that your rights are protected. You have the right to withdraw at any moment during the research and if you choose to withdraw, the data that you have provided will be destroyed. You will be required to provide a unique identifier so that I will be able remove your data from my research if you would like to no longer participate. You will be able to contact the British Stammering Association who will then get in touch with me, and your data will be destroyed.

Possible risks

There are no known risks of taking part in the research and what I am asking you to provide is not designed to upset you. Privacy Notice for Applied Criminology and Forensic Studies Research Participants

Applied Criminology and Forensic Studies research at the University of Winchester conforms to the new General Data Protection Regulation (GDPR) which came into force on 25th May 2018. The GDPR gives you the following rights

- The right to be informed
- The right of access
- The right to rectification
- The right to erase

- The right to restrict processing
- The right to data portability
- The right to object

We will only ask for personal data which is necessary for our stated research purposes and we will never sell your personal data to any 3rd party.

Even after signing a consent form, you still have the right to withdraw your consent, at any time during your research participation and for a specified period of time <u>after</u> participating in a study. The time period for withdrawing varies between studies, but will always be stated on the information sheet and/or the consent form.

All research projects at the University of Winchester are reviewed and approved by either a Departmental Research Ethics committee or the University Research Ethics committee.
