


Every legacy, no matter how small, is an amazing gesture.

HOW DO I GO ABOUT LEAVING A GIFT?

We appreciate that writing a will can be a challenging experience. We encourage anyone writing a will for the first time to give their wishes a great deal of thought, and ensure they consult their friends and family first before making a decision.

When you feel you are ready, you've made a list of who you would like to benefit from your will, what items, assets or funds you would like to bequeath, it's time to find a solicitor.
